Solution: Automated Change Auditing

That is when Eclipse Group discovered an integrated suite of NetWrix solutions that would quickly meet its change auditing needs.

Exchange Change Reporter tracks and reports all “who, what, when and where” data of all changes made to Exchange Server configuration and permissions, such as modifications to configuration settings, creation and deletion of mailboxes, information stores, Exchange servers, connectors, protocol parameters, storage groups and many other types of objects and their permissions.

Non-owner Mailbox Access Reporter detects all situations when administrators and other users with excessive rights have gained access to another user’s mailbox. The

product shows exactly who accessed what mailboxes, when, and it allows Eclipse Group to detect unauthorized activity from users with excessive or misconfigured rights, who may otherwise pose as security threats.

Proven Result: Improved Security and Peace of Mind

Since purchasing the integrated bundle of NetWrix change auditing solutions, Eclipse Group has enjoyed the newfound sense of security that comes from a well-audited IT infrastructure.

“After implementing the Exchange change reporting solutions, we were able to see who was opening mailboxes other than their own, and this allowed us to tighten our security policy,” Stainthorpe said. “In the past, unauthorized access to Exchange mailboxes has created problems for us, where employees gained access to privileged accounts in order to view confidential information via e-mail.”
