



Henry County Hospital Proves HIPAA Compliance and Saves up to \$40,000 Annually

THE CHALLENGE

Because it collects and uses protected health information (PHI), Henry County Hospital has to undergo a HIPAA compliance risk assessment every year. To comply with the regulation's rigorous data privacy and security standards, the hospital's IT team needs visibility into privileged user activity and user permissions changes, so they can prevent and mitigate insider threats. Failing to pass a HIPAA audit could result in heavy fines as well a series of more thorough OCR (Office for Civil Rights) checks, which would mean additional workload for the small, four-person IT department.

NETWRIX SOLUTION

To enable the hospital to verify HIPAA compliance through assessments with less effort and expense, the IT team began looking for an efficient solution that could monitor user activity across Active Directory, Group Policy and Windows file servers. Geoffrey Robinson, Server/Storage Administrator at Henry County Hospital, explained that the hospital chose Netwrix Auditor because it provides visibility into all required systems, and also enables video recording of the sessions of privileged users and remote vendors as an additional security layer. Leveraging the software, the team achieved the following results:

Increased accountability of privileged users. Daily reports on all changes across Active Directory and Group Policy, alerts on the most critical ones (such as changes to the Domain Admins group) and the video recording feature enable the hospital to increase user accountability and mitigate the risk of insider threats. In addition, with this information at hand, Geoffrey can address auditors' questions in a timely manner. "During the audit we have to be able to show what was changed and have an explanation of that, because we should know what is going on in our environment and prove that there is no risk to the data," he explained.

Complete control over file access permissions. Prior to the Netwrix Auditor deployment, file server permissions were granted unsystematically, putting data security at risk. Netwrix Auditor's reports and its Interactive Search feature enabled Geoffrey to detect excessive user permissions and rebuild the file server permissions from the ground up. Now he can be sure that sensitive data is accessed only by personnel who need it to perform their roles, reducing the risk of accidental or deliberate misuse that could entail security issues and noncompliance.

Time and cost savings on audit preparations. The complete infrastructure visibility and out-of-the-box HIPAA compliance reports that Netwrix Auditor provides simplify internal processes for preparing for an audit, saving the hospital at least \$40,000 per year. "To do auditing as thoroughly as we are doing it with Netwrix Auditor, we would probably have to hire another full-time employee just to do audits, because there's so much data that we need to keep track of every day," Geoffrey says.
