## Privacy regulations abound

No matter where you live, you are likely impacted by at least one privacy regulation and more continue to come into effect every year. Data privacy regulations such as CCPA/CPRA and GDPR require that organizations demonstrate compliance with data usage restrictions and adequately secure subject data from unauthorized access and data breach. However, in reality most organizations struggle to even locate where all their data exists, let alone whose information is contained within their files, applications, and databases. Further still, they struggle to understand how the data has been secured, who has access to it and if it is being handled properly.

## Hard to protect what you don't know about

To more easily locate data, many organizations have looked to implement novel approaches and technologies such as Full-Text Indexing, AI, and Machine Learning to make short work of otherwise tall tasks. Unfortunately, they've quickly realized these approaches not only fail to address the real, underlying problems, but have introduced additional complexity and risk, while requiring more time and significantly more funding that they simply do not have, especially when any real level of scale is required.

### Subject Profile


