The integrated solution simplifies the data classification task by exploiting the consistency of automation to ensure that sensitive legacy information is correctly identified before being handled by data users.

SOLUTION OVERVIEW

The integrated solution is divided into two separate but equally important components; discovery of legacy content and enforcement of data security policy.

IDENTIFY SENSITIVE CONTENT AND APPLY TAGS

In order to overcome the challenge of classifying legacy content that already exists and to utilize the classification applied to new content by users of Baldon James Classifier,



STEALTHbits scans the contents of hundreds of document types across unstructured data repositories like network file shares. This also includes image files using advanced Optical Character Recognition (OCR) technology. Out-of-the-box rules for government and industry compliance standards can be combined with criteria specific to an organization's internal policy to further streamline the process.

With a full understanding of which files are sensitive, who has access to those files, and how those files are being used, STEALTHbits facilitates the automatic application of Boldon James classification tags to the appropriate documents.

ENFORCE POLICY

Boldon James Classifier engages users in the data classification process, creating awareness and enforcing data handling policy based upon classification. Classifier applies both visual markings to content and metadata tags to data at the point of creation or manipulation, capturing the users' insight into the meaning or value of information.

In conjunction with the classification process, STEALTHbits' solutions leverage the classification tags applied by Boldon James to report on and remediate permissions to exposed sensitive files. Access to these files is monitored to maintain an audit trail and alert in real-time when these files are abused or mishandled.

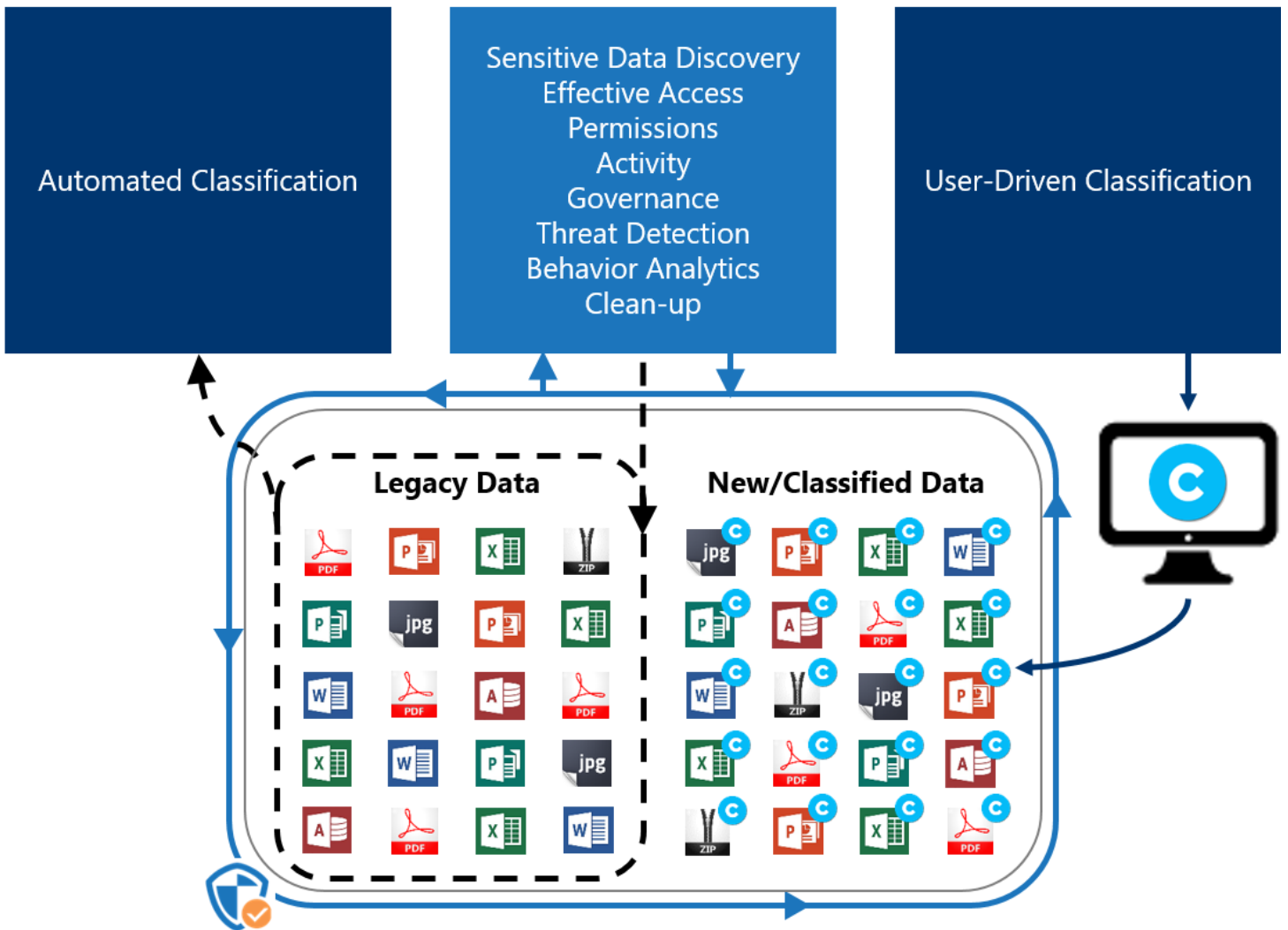
